- 1.01 Tenderers are requested to go through the instructions carefully & furnish complete information along with their tender bid offer, failing which their tender may not be considered at all. Tender shall be received in two parts; each part shall be in separate covers as under:
- a. Tender Bid part-I: Shall contain Earnest Money for **Rs. 12000.00 (Rs. Twelve Thousand only)** in the shape of FDR/CDR/TDR/ DD duly pledged in favor of Executive Engineer, Electricity Urban Distribution Division Residency Lesa Lucknow. The part-I of the tender shall also contain (i) Earnest Money (ii) "A" Class Certificate issued by Directorate Electrical Safety (iii) Registration with the Labour department (iv) Proof of credibility of their firm (v) Proof of Group Insurance of their personnel (vi) Photo copy of ITI Certificate with Electrical & Wireman Trade in respect of Skilled manpower (vii) Photo copy of certificate issued by the firm to this effect that the person has worked on LT/11 kV line atleast three years in respect of Semi skilled manpower (viii) List of agreements/ photo copies of agreements executed with them during last three years in support of their past experience/ performance.  - b. Tender Bid Part-II: Shall contain price schedule. Commercial & Technical terms & conditions. This part of the tender bid shall be superscripted "Tender Bid Part-II (Prices) against Short Tender Specification **03/EUDC-VIII/LESA/2017-18 due for opening on 17.05.2017 (Extended Date 12.06.2017) at 15:00 hrs.**
- Only such firms need tender who are having sufficient experience for carrying out such type of works during past or are authorized representative of such firms and can produce satisfactory evidence that they have necessary resources & organization to undertake the work tendered for the satisfaction of the tendering authority.
- 1.02 In case of any inconsistency of the provisions of Form 'A', the provisions under special conditions of the tender will supersede/prevail.
- 1.03 Tenderers are requested to submit the price schedule appendix duly filled in (item by item) as required & should strictly follow the instructions & notes supplementary there to facilitate the tendering authority to prepare Comparative Statements.
- 1.04 Tenderers should quote the earliest completion period of the Tendered work.
- 1.05 The portion of terms & conditions as laid down in the condition of the contract; Form 'A' enclosed along with nature of work etc. that is not clear to the tenderer should be got clarified before submission of the tender. Tenderers are requested to adhere to all clauses to the contract Form 'A' to facilitate finalization of the contract. In case, they are unable to do so, should state any particular clause of the conditions which may not be acceptable to them & should support alternative for consideration.
- 1.06 The tendering authority does not suggest pledge to accept the lowest of any tender & reserves to himself the right of rejecting the whole or any portion of the tender as he may think fit without assigning any reason for non acceptance or selection.

: 2 :

- 1.07 Tendering authority reserves the right to revise or amend the tender. Such revision & amendment, if any, will be communicated to all tenderers as amendment or addenda to this invitation of the tender.
- 1.08 Any action on the part of the tenderer to revise the price/prices and/or the change the structure of price/prices at his own instance after opening of tenders may result in rejection of tender & also debarring him from submission of the tenders to the MVVNL/ Corporation at least for one year.
- 1.09 Any approach etc., officially or otherwise on the part of the tender or his representative shall tender his offer liable to be summarily rejected.
- 1.10 Tenders of those tenderers, who have not purchased the tender specification shall not be read at the time of opening and shall be rejected outright.
- 1.11 The price of tender specification will not be refunded under any circumstance whatsoever.
- 1.12 In case of ambiguous or self contradictory terms/conditions mentioned in the tender specification, interpretations as advantageous to the MVVNL/Corporation shall be taken without any reference to accept the deviations or not.
- 1.13 Any overwriting /omitting/erasing etc. in the tender should be duly signed & stamped.
- 1.14 In no case payment will be made by the Letter of Credit.
- 1.15 In no case, MVVNL/Corporation will be held responsible to arrange the T&P for execution of the tendered work.
- 1.16 Tender Bid Part-I (Earnest Money) should contain in the shape FDR/CDR/DD issued by nationalized/scheduled bank.
- 1.17 In no. case, MVVNL will be held responsible to arrange the T&P or other equipments.
Tender Bid Part-I (Earnest Money) Should contain the following:
 - 2.01 The part one of the tender bid shall contain the Earnest Money amount to **Rs. 12000.00 (Rs. Twelve thousand only)** & documents with respect to pre-qualification of tenderer.
 - 2.02 In case part quantity offered, Earnest Money deposit shall be reduced proportionately.
 - 2.03 Tenderers are required to furnish Earnest Money amount in the form of Bank Draft/FDR/CDR of any scheduled bank duly pledged in favor of Executive Engineer Residency , LESA, Lucknow which should be submitted along with the tender bid Part-I.  - 2.04 The firm registered with DGS & D, Store Purchase Section of Director of Industries, U.P. Kanpur, U. P. Small Scale Industries Corporation, Kanpur or any other Govt. Agency/Institutions shall not be exempted from deposition of Earnest Money.
 - 2.05 The Earnest Money deposited by the tenderer will be refunded after finalization of tender, in the event of his tender being rejected/ not accepted. In the event of tender being accepted, the Earnest Money shall be retained by the tendering authority and adjusted against the security deposit specified under & the same shall be released only on satisfactory completion of work. SPECIAL CONDITIONS OF CONTRACT AGAINST TENDER NO. 03/ EUDC (8)/ LESA/2017-18

These special conditions shall be read as construed along with annexed "Conditions of Contract Form-A as modified by provisions thereof but if any conflict / inconsistency between the provisions thereof & those contained in the conditions annexed Form-A, the provisions contained in the Special conditions shall prevail.

2.0 SCOPE OF WORK

It is proposed to deploy 06 nos. skilled experienced & 12 nos. Semi skilled personnel at 33/11 KV Sub Station **G.T.I** in the area under Electricity Urban Distribution Division (**Residency**) to assist in carrying out electrical works required for execution of day to day maintenance works including but not limited to replacement of fuse wire, replacement & tightening of 11 kV & LT jumpers, insulator/ disc, repairing, restringing and sagging of broken conductor, replacement and rectification of defects in the equipments installed at pole, repairing and replacement of different sizes of underground LT cables, attending of individual consumer complaints including replacement of damaged service cable, disconnection and reconnection in the area fed through 33/11 kV substations **G.T.I** coming under the jurisdiction of Executive Engineer, Electricity Urban Distribution Division (**Residency**) LESA, Lucknow against tender No. **03/EUDC(8)/LESA/2017-18**. The manpower will report to the Executive Engineer, Electricity Urban Distribution Division (**Residency**) and the work will be allotted to them by the Executive Engineer/ Sub-divisional officer or his authorized representative.

1.0 CONDITIONS FOR WORKS AND CONTRACTORS RESPONSIBILITY:

- 3The man power deployed by the contractor shall be given the material by the representative for each job who will be acknowledge and arrange to submit detailed utilization of materials used on the works and balance return to the representative of the Corporation immediately after completion of each work.
- 1.1 Consequent upon replacement of lugs, back entry, U-type spring contacts, Copper L-pieces etc. received back scrap material from the system, will be returned to the representative of the Corporation immediately after completion of each job. The contractor shall be entirely responsible for the safe upkeep of the materials given to their manpower till completion of work to the satisfaction of the representative of the Corporation for final accounting.
- 1.2 The Contractor shall be solely responsible for any losses/ accident to the persons working with under them and shall have to pay due compensation in accordance with the prevailing rules / regulations of Government Contractor.
- 1.3 The contractor shall arrange to have group insurance for the labour deployed by them and shall have to pay due compensation in accordance with the same. The Corporation will bear no responsibility for the compensation to his manpower in case of any accident.
- 1.4 The contractor shall make payment through cheque as per prevailing rates of Minimum wages act declared by Labour Commissioner. The payment will be made to their man power in the presence of SDO concerned.
- 1.5 The contractor shall ensure that the wages to the man power deployed by them is disbursed within the first of week of each month.
- 1.6 The man power deployed by the firm, should have sufficient experience for execution of electrical works and well conversant with the electrical system.

- 1.7 The firm must be registered with the Labour Department and the names & address of their personnel should have been mentioned in the list. Proof of initial registration with the Labour Department will be submitted by the firm to the Executive Engineer, Electricity Urban Distribution Division (**Residency**) also for the number of personnel deployed by them against this agreement.
- 1.8 The firm will be responsible to deduct the amount of E.P.F. from the wages of their employees and contribution of the firm, will be got deposited with the E.P.F. Commissioner as per rules and regulation and provide a photocopy of Deposited E.P.F. amount in concerning Executive Engineer Distribution Division office before making payment.
- 1.9 The age of the man power deployed by the firm, should be in between 18 years to 55 years. Proof of the age of the manpower deployed by the firm, will be submitted by the contractor to the concerned authority.
- 1.10 Concerned officer of UPPCL have no right to issue any type of experience certificate in respect of man power deployed by the firm.
- 1.11 Character certificate of each employee deployed by the firm, will be made available to the department.
- 1.12 The firm will be responsible to get the undertaking from each employee that they will never precede to the court against Madhyanchal Vidyut Vitran Nigam Limited and copy of the same will be submitted to the department.
- 1.13 Identity Cards will be issued by the firm to the Man Power deployed by them and the same will be kept by the employees while on duty.
- 1.14 The services of the manpower deployed by the Contractor can be utilized in any division under the jurisdiction of Electricity Urban Distribution Circle-8, LESA, Lucknow, if required.
- 1.15 The contractor must submit the list of man power with their attested photocopies of I Cards, Bank Account No and Employees E.P.F No, to concerning Executive Engineer Distribution office.
- 1.16 On availability of Semi skilled manpower through any other resources corresponding number of unskilled labour will be removed from the agreement number of persons.
- 2.0 **RATES:** The above rates are variable in case D.A. is revised by the labour department during the currency of the contract. The liability of Government taxes & duties applicable consequent upon deployment of manpower will be born by the firm.
- 3.0 **SERVICE TAX:** In addition to above rates, the service tax will be paid to the contractor @ 15% or as applicable at the time of payment.
- 4.0 **CONTRACTOR'S REPRESENTATIVE:** The names of the authorized representative, if any and their local address, will be intimated by the contractor within one week time, from the date of execution of agreement. The contractor will intimate to the Execution Authority/ Engineer of contract, changes if any, in the local address of the contractor's representative immediately on occurrence of any change. The responsibility for non receipt of intimation due to change in address will be on the contractor.
- 5.0 **SUBLETTING OF THE CONTRACT:** The Contractor shall not assign or sublet the contract/ work to any other party/ person, without prior written permission from the Engineer of the Contract.

- 6.0 **SECURITY DEPOSIT:** Security deposit @ 5% will be deducted from the running bills of the contractor by the payment authority while making payment as per existing rules of the Corporation and the same will be refunded on satisfactory completion of contractual period. The contractor may also deposit the security in the shape of Bank Draft/ FDR/ CDR duly pledged in favour of Work Execution Authority/ Engineer of Contract. In case the amount of Security deposit exceeds Rs. 5000.00 the same may also be deposited in the form of Bank Guarantee issued by the scheduled bank of India duly executed on a non – judicial stamp paper of entire work. The Bank draft/ FDR of Bank Guarantee should be valid at-least for the contractual period.
- 7.0 **PAYMENT:** Payment shall be made once in a month by the Executive Engineer, Electricity Urban Distribution Division (**Residency**), LESA, Lucknow to the contractor for the no. of Manpower as per allotment deployed by the firm during the month on certified measurement subject to availability of funds.
- 8.0 **PENALTY:** In case, any personnel deployed by the contractor found absent at any time during his duty period, will be treated as absent for full shift duty and just double of the amount payable to one no. unskilled personnel for one shift, shall be deducted from the bills of contractor.
- 9.0 **ARBITRATION/ SETTLEMENT OF DISPUTE:** In case of any dispute arises in between the Contractor and the engineer of contract, the decision of Chief Engineer (LESA), will be binding on both the parties. All disputes arising out of contract shall be related to the jurisdiction of local courts of district, Lucknow & High Court of Judicature of Allahabad.
- 10.00 **TERMINATION OF AGREEMENT:** The agreement can be terminated by the Engineer of the Contract at any time by giving one months notice in the event of unsatisfactory performance of the contractor. This is however without prejudice to the offer and terms and conditions of the agreement.
